Rx Exchange Program Overview

Our Rx Exchange Program enables you to exchange any unopened medication purchased from Specialty Veterinary Pharmacy (SVPMEDS) that expired in the past 30 days and qualifies. Simply pay the cost of shipping your expired medication and the cost of shipping your replacement order.

The Rx Exchange Program keeps you from throwing away money on expired inventory. It reduces your annual medication cost – and improves your bottom line.



To get started, after reading the Rx Exchange Program Terms below, if you qualify, complete the Rx Exchange Return Form. Then package up any expired medication that qualifies and ship it to SVPMEDS. After receiving your package, we'll promptly ship your new medication.

Rx Exchange Program Terms

- 1. We only accept unopened, unused, expired medications compounded by SVPMEDS.
- 2. Your return shipment of expired medication must be postmarked within 30 days of its expiration date.
- 3. SVPMEDS sends replacement medication only after receiving expired medication.
- 4. You're responsible for the cost of shipping returns to SVPMEDS.
- 5. Only licensed U.S. veterinarians qualify for the Rx Exchange Program.
- 6. You must have a valid email address to participate in this program.
- 7. An Rx Exchange Return Form is required with all returned medications.
- 8. Controlled substances, chemotherapy drugs, commercially available medications, and medications not purchased from SVPMEDS do not qualify for this program.
- **9.** A shipping fee of \$7.75 is charged to ship replacement medication.
- **10.** SVPMEDS is not liable for lost shipments of medications being returned for replacement.
- **11.** When replacing expired medication that qualifies, if an exact match isn't available, we'll dispense an appropriate substitute medication decided upon by the veterinarian and pharmacist.
- **12.** If you choose, you can receive a 75% credit of the original cost of the expired medication instead of a replacement order.

SVPMEDS reserves the right to terminate the Rx Exchange Program or amend its terms at any time.
